Dear Mr. Larson:

On September 11, 2015, the U.S. Environmental Protection Agency (EPA) issued a Stop Sale, Use, or Removal Order (“SSURO”) to sBioMed, LLC (“sBioMed”), the registrant of two pesticide products that EPA had reason to believe were misbranded and were being sold or distributed: Steriplex SD Part A, EPA Reg. No. 84545-11, and Steriplex SD Activator Part B, EPA Reg. No. 84545-10 (together, “Steriplex products”).

On January 18, 2018, sBioMed submitted applications to amend the registrations of each of the Steriplex products in order to address the basis for the SSURO and bring the products into compliance with FIFRA. On September 18, 2018, the EPA’s Office of Pesticide Programs (OPP) accepted sBioMed’s amended labels and amended confidential statements of formula for the two Steriplex products. OPP noted that alternative brand names have been added to the record: Axeniplex Pharma (Part B) and Axeniplex Lifescience (Part B) for EPA Reg. No. 84545-10, and Axeniplex Pharma (Part A) and Axeniplex Lifescience (Part A) for EPA Reg. No. 84545-11. OPP accepted the amended registrations with conditions related to final printed labels and post market testing, and noted that sBioMed’s release for shipment of the products after September 18, 2018, would constitute acceptance of those conditions.

On September 21, 2018, an agent for sBioMed requested that EPA modify the SSURO to permit sales and distribution of Steriplex products compliant with the amended registrations.

By this letter, the September 11, 2015 SSURO issued to sBioMed is modified to permit sBioMed to sell and distribute the Steriplex products identified by EPA Reg. Nos. 84545-10 and 84545-11, provided the products are labeled and formulated consistent with the September 18, 2018 amendments to their registrations and are otherwise in compliance with FIFRA. The SSURO is still in effect as to any stocks of Steriplex products that are misbranded.
