#### **Highlighting Tribal Environmental Protection and Restoration Projects**

A video will be shown featuring work that the staff from the Grand Portage Band are doing to understand climate change impacts to the moose population in Minnesota.

"The Anishnaabe, or Ojibwe, have lived on the land we now call Minnesota since long before European settlers arrived. For as long as they can remember, their lives have been intertwined with that of the moose. It's more than a source of food — it's also a way of staying in touch with their ancestors, who carved game pieces from the antlers, fashioned elaborate clothing from the hides, and used the hair to embroider intricate designs on everything from stockings to cradleboards. But this relationship between the Anishnaabe and the moose is in danger. The moose population has been in free fall for the past two decades. Something else is killing the moose."

#### **Protection of Ceded Territories/Treaty Rights**

Alan Walts; TMPO Director At the March 2021 RTOC meeting, the RTC indicated that protection of ceded territories/treaty rights is one of their priorities for working with EPA. The RTOC will continue that discussion with a "tabletop exercise" that walks through a hypothetical situation where the EPA Policy on Consultation and Coordination with Indian Tribes: Guidance for Discussing Tribal Treaty Rights might be used and how EPA and impacted tribes would work together.
