Identifying Partnership Opportunities for Climate Change

EPA Direct Implementation (DI) Activities in Indian Country

The RTC identified DI as one of its nine priority areas, and recently the EPA Office of International and Tribal Affairs indicated that ensuring EPA is meeting its DI responsibilities in Indian country will be a significant activity over the next few years.

In follow-up to this meeting, focused discussions on EPA DI responsibilities under the Clean Air Act, Clean Water Act, and the Resource Conservation and Recovery Act will be scheduled with the RTC to discuss options for tribal involvement and enhancing related tribal program capacities.
