Dear Ms. Gilles-Parker:

Syngenta Crop Protection, LLC, is requesting a three year exclusive use data extension for products that contain Benzovindiflupyr (trade name Solatenol®), registered August 28, 2015 for 14 commodities, many of which are minor uses. Several more minor uses were registered later, up through 2020. Syngenta believes that all of the pertinent criteria outlined in FIFRA 3(c)(1)(F)(ii) have been satisfied for more than the required 9 minor crops and the details are described in the enclosed Exclusive Use Extension Petition for 20 minor uses.
