What is Asthma Awareness Month?




EPA seeks to raise awareness on asthma during Asthma Awareness Month in May



Asthma is a serious, sometimes life-threatening chronic respiratory disease that affects the quality of life for more than 25 million Americans, including an estimated 4 million children.



Although there is no cure for asthma yet, asthma can be controlled through medical treatment and management of environmental triggers.




EPA is committed to educating all Americans for everyone to know what asthma is, how the environment can affect asthma patients, and how to manage environmental asthma triggers with an asthma action plan.

How Can it Impact You?



Anyone can get asthma.



25 million people have asthma in the United States



About **3 students** in an average classroom of 30 have asthma.

1

1 out of every 10 school-aged children suffering from asthma



Asthma accounts for more than **10.5 million missed school days** each year in children aged 5 to 17.



Air Pollution Monitoring of Methane Emissions

Landfill Gas (LFG) is a natural byproduct of the decomposition of organic waste (ex: food scraps) in landfills.


LFG is approximately **50% methane**, which is a potent greenhouse gas (GHG) — it's 28x more effective than CO₂ at trapping heat in the atmosphere.¹

12% of all U.S. greenhouse gas emissions is methane.²

15% of methane emissions come from landfills.

In 2021, methane from U.S. landfills equated to the total CO₂ emissions of **13.1 million homes' energy use for 2020**.³

EPA's funding for **air pollution monitoring** will support ways to reduce potent methane emissions.

EJ Thriving Communities Grantmaking Program

TCGM cooperative agreements are collaborations between EPA and 11 grantmakers around the nation to reduce the burden of the federal grants application process and distribute federal funds to potential applicants working to address environmental justice issues.

1,000+ Thriving Communities Subgrants distributed by grantmakers will:



Support capacity-building through assessment, planning and project development.



Increase efficiency and **reduce barriers** to accessing federal grant funding.



Encourage meaningful involvement of community members in decision-making that may affect their communities.

Funding Options & Types of Projects for Future Grantmaker Subawardees

Phase 1 Assessment Projects up to \$150,000 (1 year)

Ex: Research (that is incidental to the project design) • sampling • testing • monitoring • investigations • surveys and studies • public education

Phase 2 Planning Projects up to \$250,000 (1-2 years)

Ex: Planning • Partnership-building • Public outreach and education • Coordination with community stakeholders to address environmental issues • Training activities for community organizations and community members • Projects and activities to spur community involvement (e.g., cleanups of vacant lots) • Smaller land purchases & acquisitions that require less than half the total amount of subgrant

Phase 3 Development of Projects up to \$350,000 (2 years)

Ex: Project Development • Blueprints for construction or cleanup projects, schematics, and technical development • Work to get permits in place directly related to an environmental project • Smaller land purchases and acquisitions that require less than half of the total amount of subgrant funding • Implementation of project plans • Public outreach and education

***A limited number of \$75,000 non-competitive fixed-amount subawards will be available for severely capacity-constrained CBOs to access.**

EJ Thriving Communities Grantmaking Program (TCGM) Subgrants

Applicants eligible to apply for Thriving Communities subgrants this fall include:

- Nonprofit organizations, community-based and grassroots nonprofit organizations
- Tribal governments (both federally recognized & state-recognized) and intertribal consortia
- Local governments
- Institutions of higher education
- Native American Organizations
- Puerto Rico
- US Territories
- Freely Associated States (FAS)

Ineligible subrecipients include:

- Individuals
- For profit businesses
- State governments

Environmental and Climate Justice Community Change Grants Program

Through the Inflation Reduction Act, EPA will invest about \$2 billion for environmental and climate justice activities benefiting communities most impacted by climate change, legacy pollution and historical disinvestments.



About \$2 Billion

The Community Change Grants are designed to:



Engage disadvantaged communities in government processes.



Invest in place- and community-based initiatives.



Reduce pollution with community-led pollution monitoring, prevention and remediation.



Increase climate resilience and community capacity to respond to environmental and climate justice challenges.



Community Change Technical Assistance Program

Through the Inflation Reduction Act, EPA's \$200 million technical assistance program will help eligible entities apply for and manage Community Change Grants.

Total Funding

\$2 billion - single largest investment in environmental justice going directly to communities in history

Open Now until **Nov 21, 2024**

March 2025: initial award selections

June 2025: anticipated start for initial selections



Track I

- \$10-20 million each, 150 awards
- Community-driven investments for change
- Maximum 3 years

Track II

- \$1-3 million, 20 awards
- Meaningful engagement for equitable governance
- Maximum 3 years

Who can apply?

A partnership between at least two community-based non-profit organizations (CBOs).

A partnership between a CBO and one or any combination of the following:

- 1) Federally-Recognized Tribe
- 2) Local Government
- 3) Institution of Higher Education

Internship Program

The 4-Week (16 Total Hours) Internship Program introduces regenerative agriculture and growing in the Ozarks through field work at SCG farm locations, and workshops led by industry professionals.

The majority of participants were between the ages of 31-40; approximately 15% identified as active military or a veteran; 68% were female; 26% identified as persons of color; (and this represents nearly 10% more people of color than represented in the overall population.)



Springfield Community Gardens offers two short term programs at our urban farm incubators for those interested in jumpstarting careers in regenerative agriculture.

Farmer Apprenticeship

- Paid: Living Wage
- 40 hours per week for nine months
- Workshops and training (in-person and remote) with industry professionals
- Mentorship by SCG farmers
- Land acquisition opportunities
- Completion certificate

Farmer Internship

- Unpaid
- Four hours per week for one month
- In-person workshops and training with industry professionals
- Completion certificate

Results

- 100% completion with 26 graduates
- Intern hired as processing manager at Cox Health hospital farm
- Two interns are teachers at the Darr Ag Academy at Springfield Public Schools
- A 2023-24 EPA Environmental Justice Collaborative Problem Solving grant continues the program with a 4-week and 16-week internship for 108 interns.

Purpose & Goals

Purpose: Water and Garden Soil Testing for Rural Latino Families

Goals:

- ❖ Rural Latino families understand water and soil contamination issues that could affect them
- ❖ Rural Latino families and small-scale farmers understand how to prevent water and soil contamination at their homes and farms
- ❖ Participants learn to access resources and technical service providers who can help them overcome water and garden soil issues
- ❖ Targeted areas Lexington, Columbus, West Point and Grand Island

Activities

- Outreach to targeted communities regarding learning circle trainings.
- Trainings are focus on soil and water contamination. These can be done at community gardens, farms, public water and private wells.
- Demonstrations will be done during these trainings, such as soil and water testing.
- Publishing, creating and promoting videos showcasing water/soil testing sampling and reading tests

Activities (cont.)

Twenty-four Latino participants need to:

- ▷ Learn about water and soil quality issues
- ▷ learn to test and read water results
- ▷ learn to test and read soil results



Six farmers need to:

- ▷ learn to prevent water and crop contamination

All of these activities were bilingual or Spanish Only.

Deliverables completed

- The Center completed a wellhead protection plan in Spanish and English. This resource is housed on the Center's website.
- We also provided 29 water kits and 16 soil kits during the water and soil testing events to both farmers and home gardeners.
- The Center produced Spanish video tutorials on how to conduct a water and soil test. Within the videos we explained how to fill out the English forms, and provided a Spanish template to help them fill out the forms. The video tutorials currently can be accessed in the Center's YouTube channel.



Lessons Learned

- ★ Lean on partners.
- ★ Information needs to be translated.
- ★ Remain flexible and communicative.
