EPA's Meaningful Involvement Policy Update

Key Points of the Meaningful Involvement Policy

Primary audiences: EPA Teams (e.g., staff, managers, fellows, interns, appointees, senior executive service, contractors, and senior environmental enrollees)

Purpose: Promote a consistent EPA-wide approach to providing meaningful engagement opportunities and support EPA employees in doing this work effectively

Aligns with and is responsive to: Administration priorities, E.O. 14096, the Equity Action Plan, and OMB's Office of Information and Regulatory Affairs (OIRA) guidance on broadening public engagement



This policy aims to:

- Reaffirm EPA's commitment to early and frequent outreach, accessibility, and meaningful engagement.
- Establish a clear and effective process for providing meaningful engagement and public participation opportunities.
- Promote a wide variety of practices to create early and continuing opportunities for public participation in EPA actions, (including regulatory & non-regulatory decisions and activities, when appropriate.)
- Ensure EPA makes decisions with an understanding of the interests and concerns of the interested and affected public.
- Improve efficiency, equity, and transparency of EPA's decisions, consistent with applicable laws and regulations.

EPA's Meaningful Engagement Policy outlines three steps to help EPA teams design an appropriate and effective process for meaningful engagement and public participation.



Step 1: Understand the EPA Action and Key Issues the Public Can Inform



The first step is to understand the EPA action and identify opportunities to make decisions, knowing what decisions have already been made, and understanding the legal requirements. This understanding will help EPA teams identify the required or most effective time in the process to ask for public input and share this input within EPA to help make decisions.



Step 2: Identify the Expected Level of Participation Using EPA's Public Participation Spectrum

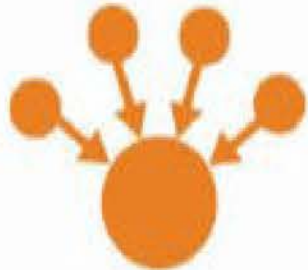


The second step is to use EPA's Public Participation Spectrum, which includes guiding questions, to select an appropriate level of participation for planning purposes. This spectrum describes five levels of public participation to help EPA teams set and communicate clear expectations about how they intend to provide opportunities for meaningful engagement.

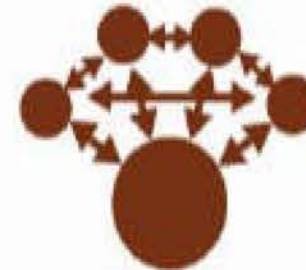

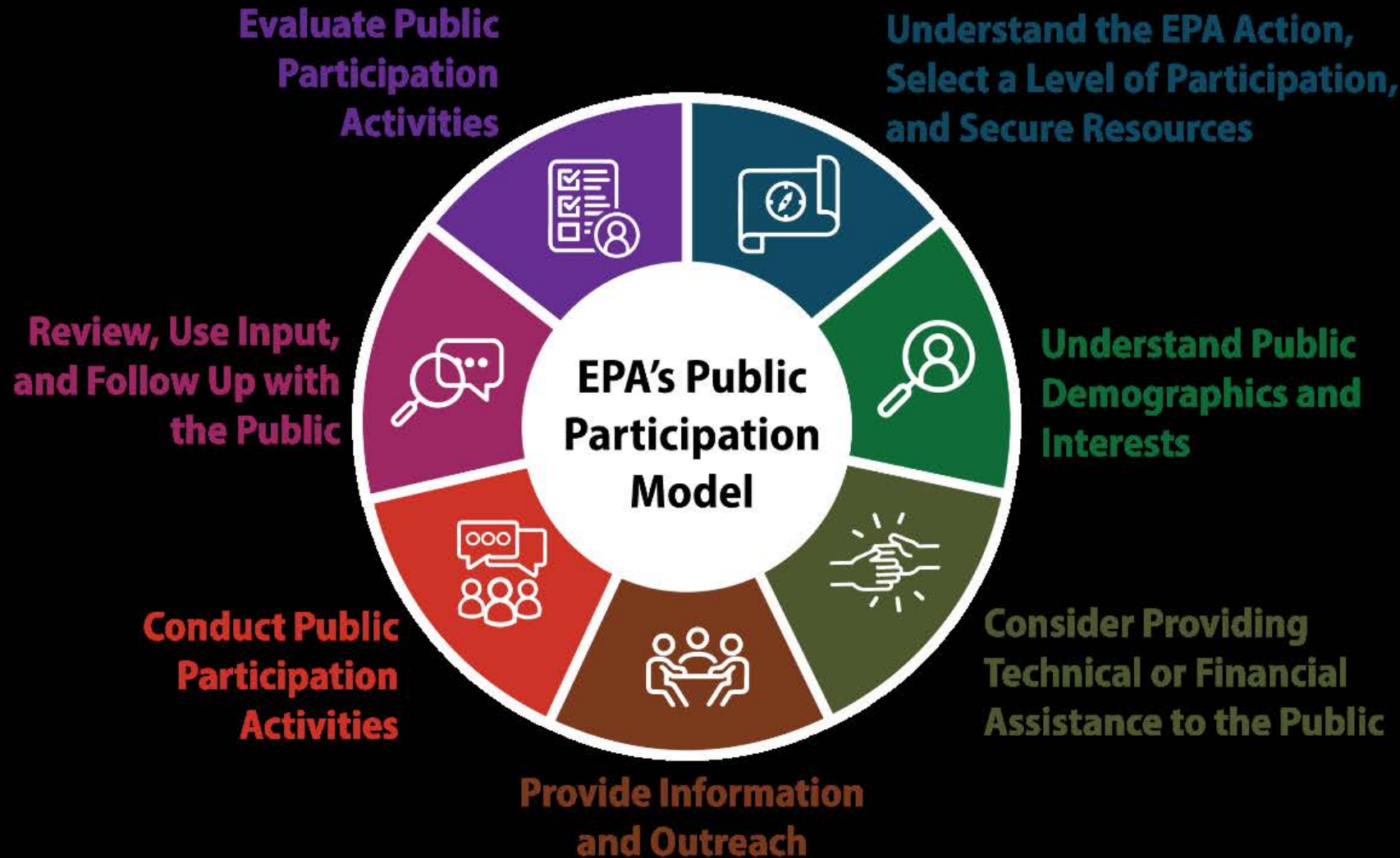


Step 3: Identify the Appropriate Engagement Tools and Practices Using EPA's Public Participation Model



After identifying the appropriate level of public participation, EPA teams can use EPA's Public Participation Model to select tools and practices that help provide opportunities for meaningful engagement. The right tools and practices can help EPA teams meet the promise to the public identified in the Public Participation Spectrum. This iterative model for helping achieve health and environmental protection includes seven stages.

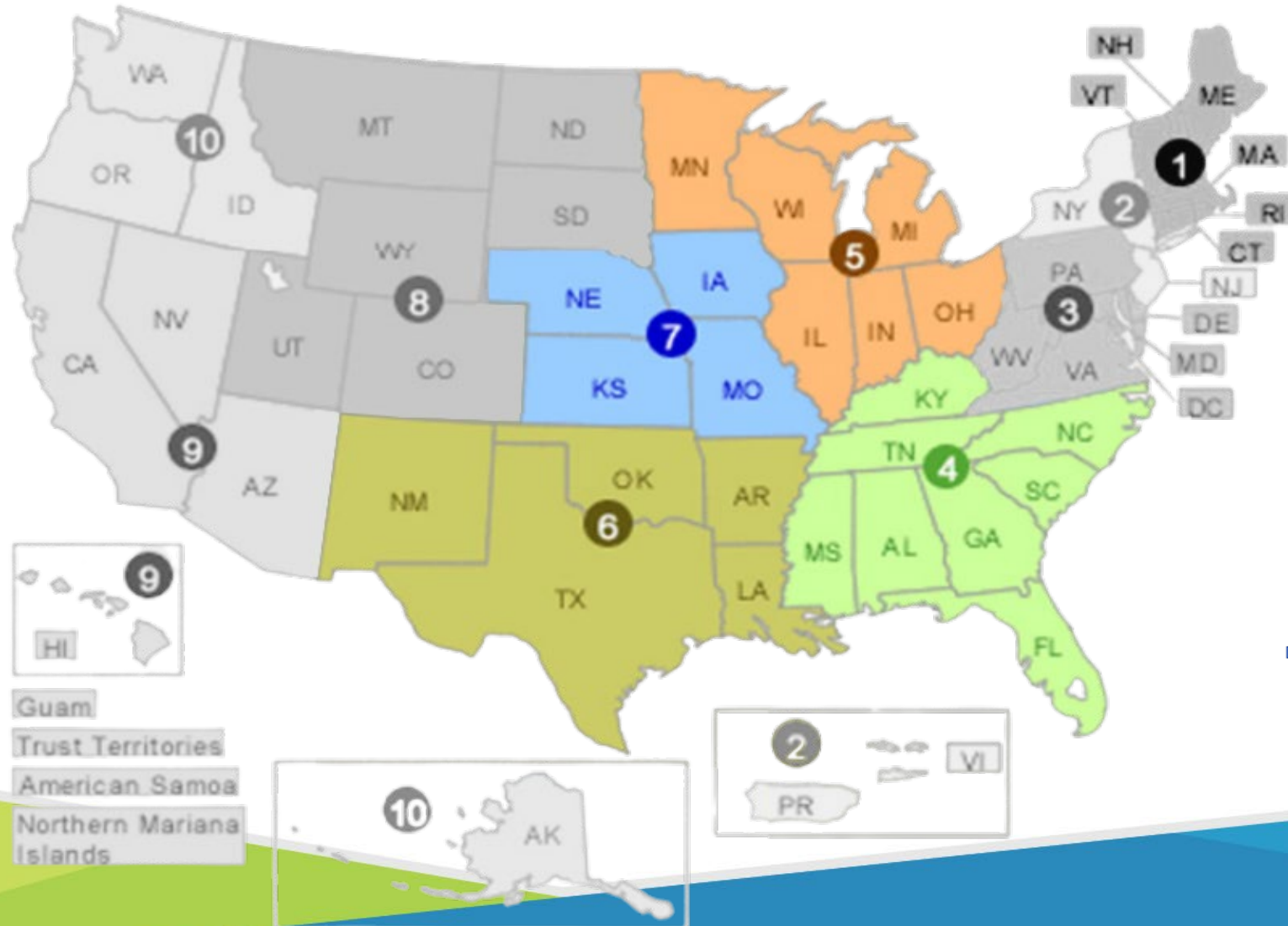

RTI's Program Overview

- ▶ Role as a conduit and **facilitator** of a set of coordinating activities that will reach underserved and disadvantaged communities
- ▶ Advance racial equity by positioning **community members as decision makers** in selecting recipients of the competitive and noncompetitive awards
- ▶ Build broad **awareness** of the EJ TCGM Program and support key communities in applying for funding
- ▶ Implement an **easy, accessible** grant application process and support grantees as they carry out their projects

Range of different environmental project activities, including (but not limited to) small local clean ups, local emergency preparedness and disaster resiliency programs, environmental workforce development programs for local jobs reducing greenhouse gas emissions, fence line air quality and asthma related projects, healthy homes programs, and projects addressing illegal dumping.

Eligibility for TCGM Grants

- Nonprofit organizations, community-based and grassroots nonprofit organizations
- Philanthropic and civic organizations with nonprofit status
- Tribal governments (both federally recognized and state-recognized) and intertribal consortia (i.e., a partnership between two or more tribes that work together to achieve a common objective.)
- Local governments
- Native American Organizations (includes Indian groups, cooperatives, nonprofit corporations, partnerships, and associations that have the authority to enter into legally binding agreements)

Ineligible recipients include: Individuals, for-profit businesses, state governments



TCGM subgrants may address a variety of issues:

- Air quality & asthma
- Fence line air quality monitoring
- Monitoring of effluent discharges from industrial facilities
- Water quality & sampling
- Small clean-up projects
- Improving food access to reduce vehicle miles traveled
- Stormwater issues and green infrastructure
- Lead and asbestos contamination
- Pesticides and other toxic substances
- Healthy homes that are energy/water use efficient and not subject to indoor air pollution
- Illegal dumping activities, such as education, outreach, and small-scale clean-ups
- Emergency preparedness and disaster resiliency
- Environmental job training for occupations that reduce greenhouse gases and other air pollutants
- Environmental justice training for youth

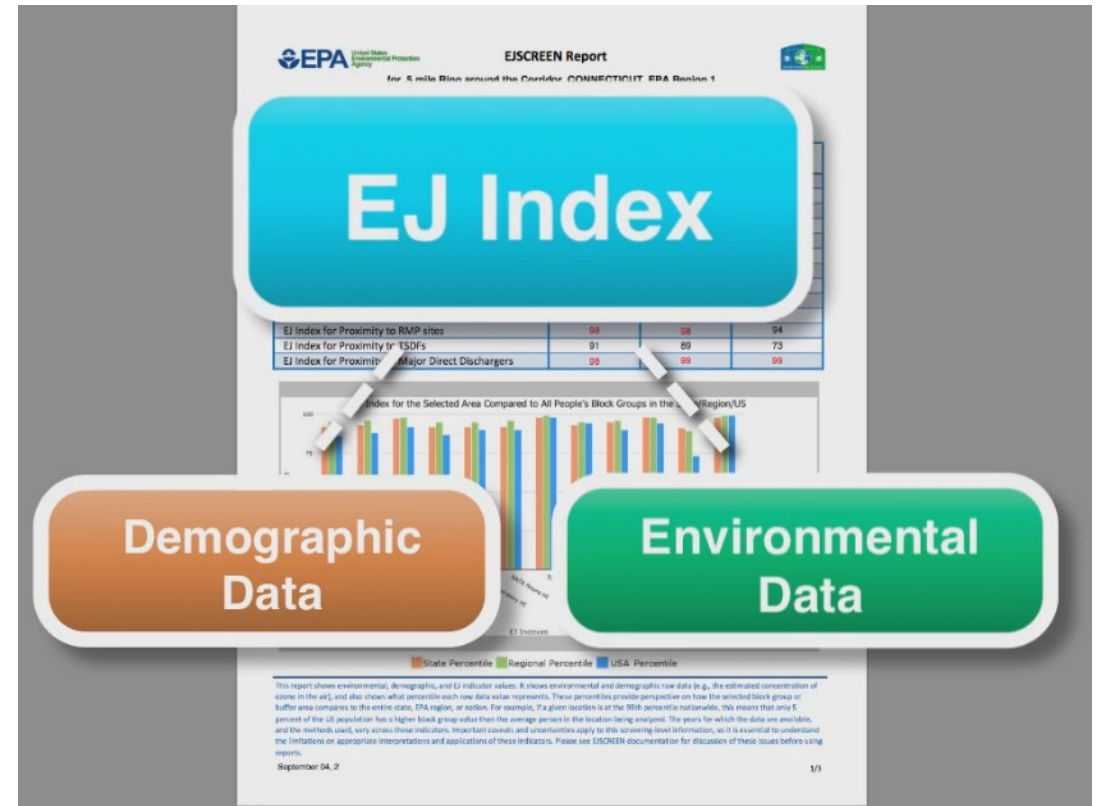
What is EJScreen?

- ▶ EPA's web-based GIS tool for nationally consistent EJ screening and mapping
- ▶ Combines environmental and socioeconomic data to highlight areas where vulnerable populations may be disproportionately impacted by pollution
- ▶ Starting point for agency considerations of environmental justice



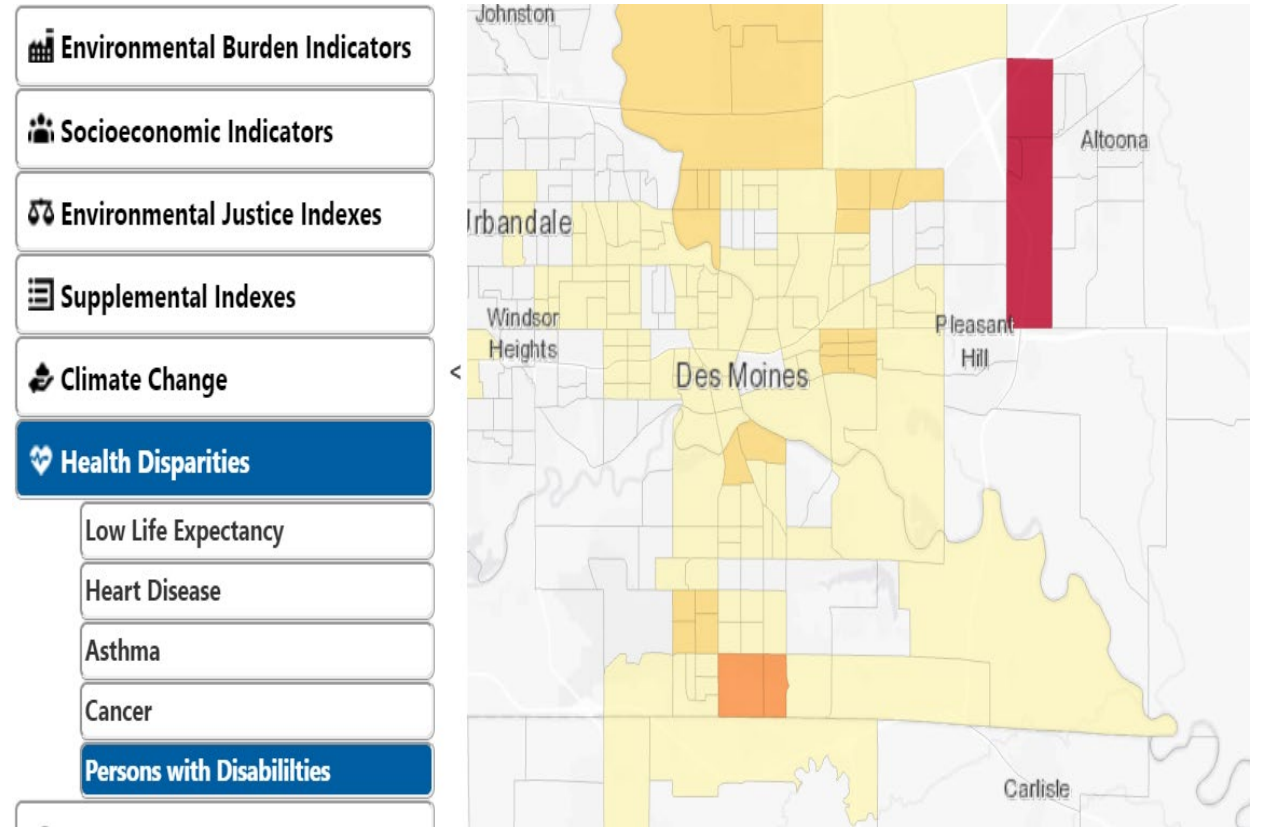
Primary EJScreen Datasets

- 13 EJ Indexes
- 13 Supplemental Indexes
- Environmental (13 indicators)
- Socioeconomic (7 indicators)
- Health (5 indicators)
- Climate (5 indicators)
- Critical Service Gaps (5 indicators)



EJScreen Key Features

- ▶ Annually updated environmental data
- ▶ Annually updated demographics - from most recent U.S. Census Bureau American Community Survey (ACS)
- ▶ Highest resolution data available
- ▶ Locations of community interest can be overlaid via the “Places” tab
- ▶ Produces maps, graphs & reports
- ▶ Ability to download data
- ▶ Accessibility / ease of use

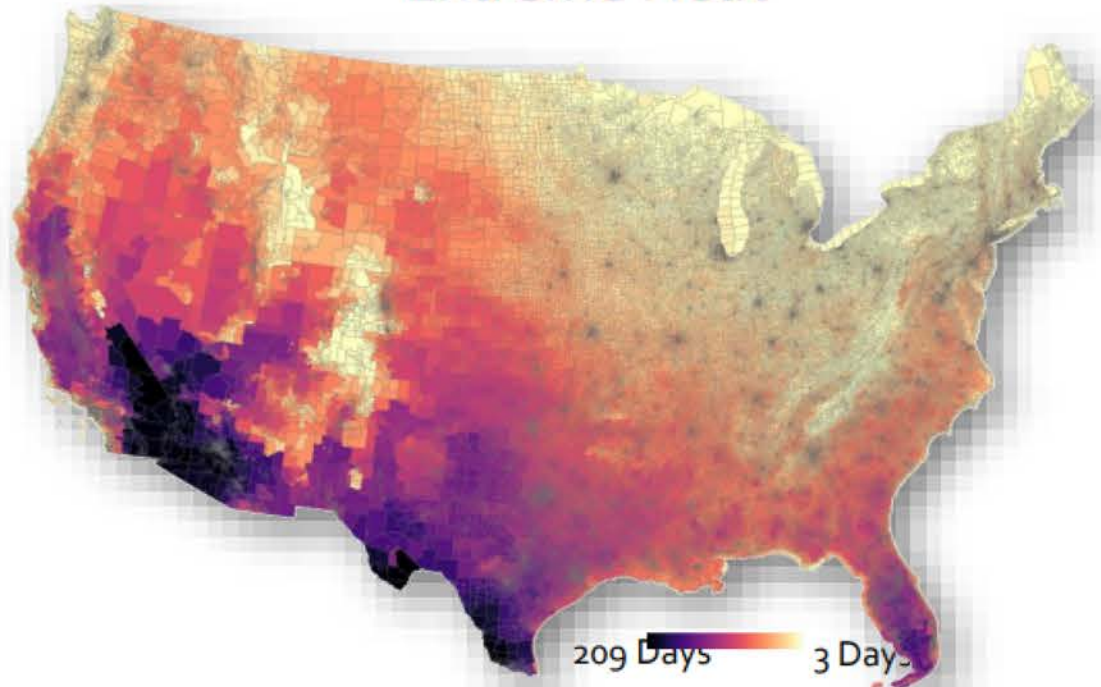

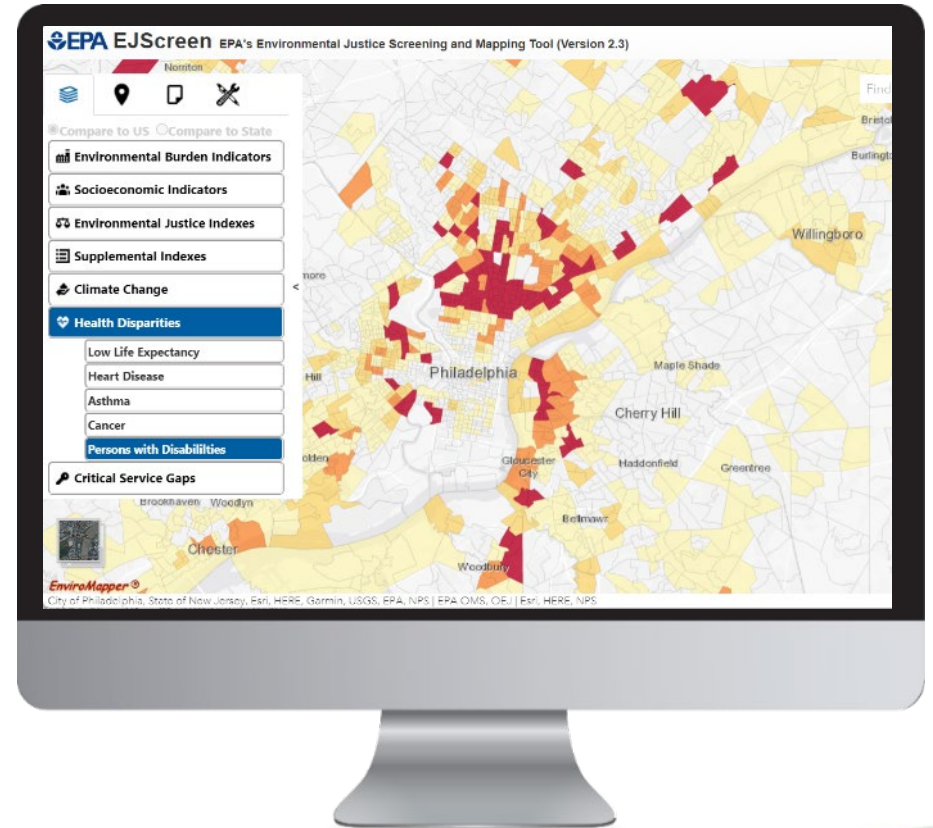

What is AmeriCorps?



- ▶ Federal agency derived from Domestic Volunteer Service Act (DVSA) of 1973
- ▶ Network of national service programs that improve lives and foster civic engagement
- ▶ **V**olunteers **I**n **S**ervice **T**o **A**merica

Who Are VISTA Members?

Eligibility

- ▶ 18+ years of age
- ▶ U.S. citizens or legal permanent residents
- ▶ Must pass a criminal history review
- ▶ Local or national recruits
- ▶ May have specific knowledge, skills, or abilities required by the host site and/or sponsor

Benefits

- ▶ Biweekly living allowance
- ▶ End of Service award
- ▶ Health benefits
- ▶ Professional development
- ▶ Non-competitive eligibility



What VISTA Members Do

Each VISTA member works **full-time** for **one year** at a host site and can...

Create Partnerships

- Community outreach
- Event planning
- Improving communications

Build Volunteer Management Systems

- Engage and coordinate
- Recruitment
- Design databases

Expand Current Programs

- Marketing
- Evaluation and continuous improvement
- Create maps

Leverage Cash & In-Kind Resources

- Grant writing
- Fundraising

While individual VISTA members only serve one year, the projects they work on can last up to three years

What VISTA Members *Don't* Do

- ▶ International work
- ▶ Religious activity
- ▶ Certain political activities:
 - ▶ Hatch Act
 - ▶ Voter registration
 - ▶ Union organizing
- ▶ Supplanting staff or existing volunteers
- ▶ *Direct service activities*



Direct Service vs Indirect Service



Capacity Building (Indirect Service)

Interpret and instruct on environmental law or policy
Conduct outreach and programs
Implement a recycling program
Develop, expand, and process improvement
Revitalize dilapidated buildings
Develop database that tracks buildings and resources needed to revitalize buildings

Tasks and activities to expand the scale, reach, efficiency, or effectiveness of specific antipoverty projects

Important Notes



★ **VISTA members will not represent EPA**

- ▶ VISTA members are not federal employees, interns, or free labor—they are AmeriCorps Members.

★ **Projects are not limited to EPA delegated authorities**

- ▶ Projects do not have to be solely focused on activities that EPA has authorization to do under its environmental programs.

★ **Projects are identified and managed by host sites**

- ▶ Host sites submit project ideas to EPA.
- ▶ EPA and AmeriCorps select projects.
- ▶ EPA supports projects by taking on administrative burden, providing training and technical guidance.

Criteria for Being a Green VISTA Corps Host Site

- ✓ Be a public, private, or faith-based nonprofit organization or a local government agency.
- ✓ Serve significant low-income and/or historically underserved communities in the EPA Region 7 geographic area (Iowa, Kansas, Missouri and Nebraska).
- ✓ Serve communities recognized as overburdened and that have been significantly impacted by at least one EPA Environmental Justice index.
- ✓ Have resources available for members to perform their tasks (i.e., workspace, consumable supplies, computer access, telephone, on-the-job transportation reimbursement, etc.).
- ✓ Have the capacity and commitment to train, supervise, and otherwise support recruited VISTA members in appropriate capacity-building roles.
- ✓ Be experienced in the issues related to the beneficiaries of service and those being addressed by the proposed project.

Example Green VISTA Corps Project Activities



Assist local nonprofit watershed groups in planning, developing, implementing, and evaluating projects to mitigate nonpoint source pollution in low-income communities.



Conduct educational outreach and provide resources on healthy homes, asbestos management, lead-based paint, and pesticides to populations experiencing racial inequity.



Build capacity for and provide short-term resources to land revitalization groups looking to clean up dilapidated buildings, with the long-term goal of building low-income or senior housing.



Expand air pollution monitoring capabilities, provide education to, and research opportunities to bridge the gap between geographic boundaries in vulnerable communities.



Assist non-profit and tribal organizations in grant writing to support environmental programs.

Why Be A Green VISTA Corps Host Site?

- Hands-on support to your organization from a VISTA member in building programs that benefit your community.
- Reduced administrative burden compared to hosting a VISTA on your own.
- Project development and technical assistance from federal partners.
- Training and teambuilding opportunities for your VISTA member.

IOWA ENVIRONMENTAL COUNCIL (IEC)

- ▶ IEC is a statewide nonprofit organization and is the largest environmental coalition in Iowa.
- ▶ Our values:
 - ▶ Our work is informed by science, data, and stories
 - ▶ Sometimes we educate and lead; other times, we learn and follow
 - ▶ We are inclusive, non-partisan, and we listen to others
- ▶ Our mission is a just, healthy environment and a sustainable future for all Iowans.



IEC'S APPROACH TO ENVIRONMENTAL JUSTICE

- We are committed and we play a role.
- Our role is to elevate local solutions to implement change.
- Our work is data driven and strategically planned to benefit the lowans with the greatest need.
- Disadvantaged communities facing environmental justice burdens are also diverse and/or low-income.



IEC's CLIMATE INITIATIVES PROGRAM

The Climate Initiatives Program advances a future where Iowans and the communities they call home are resilient to the impacts of climate change.

Four pillars:

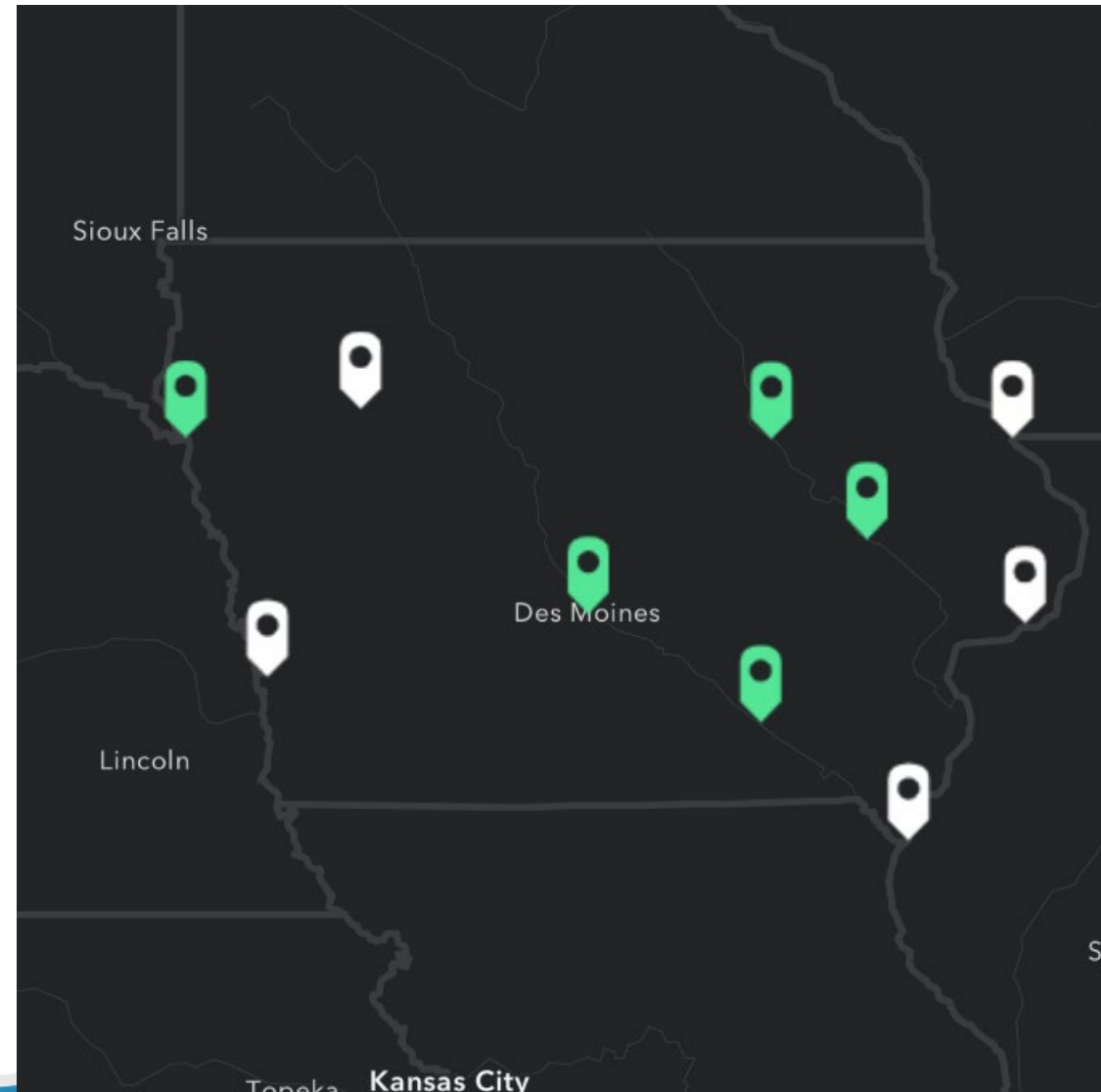
- ← **Environmental Justice**

TARGET COMMUNITIES With EJ CONCERNS IN IOWA

IEC identified five communities (out of those defined as disadvantaged) where we will focus our environmental advocacy. These include **Sioux City, Des Moines, Ottumwa, Cedar Rapids, and Waterloo.**

Other communities, such as **Storm Lake, Council Bluffs, Keokuk, Dubuque, and Davenport** also showed high indicators of environmental burden.



IEC'S EPA AWARDED GRANTS



EPA EJ GOVERNMENT-TO-GOVERNMENT GRANT

Goals:

- Increase EJ engagement and capacity in Iowa
- Highlight EJ hazards inside and outside the home

Milestones:

- Environmental Justice Health Equity Program with trained local navigators
- Reach & connect underserved populations

INCREASING HEALTH EQUITY AND AWARENESS

- ▶ Focus on environmental health hazards such as:
 - lead services lines
 - lead paint
 - poor air quality
- ▶ Learn about community-specific health equity challenges.
- ▶ Work with community-based partners to train their selected EJ navigators to address challenges.



EPA EJ COLLABORATIVE PROBLEM-SOLVING GRANT

► Goal:

- Build leadership and capacity for EJ in Iowa

► Milestones:

- Build & train EJ Cohorts in 4 communities
- Share funding resources
- Equip communities with project plans

► Key Partners:

- Drake University
- Great Plains Action Society
- Polk County
- Iowa Department of Health and Human Services



BUILDING LEADERSHIP FOR JUSTICE

- ▶ Local CBO partners select cohort participants, IEC helps train them and learn from their lived experiences to identify EJ issues in their community.
- ▶ IEC trains EJ cohorts to build understanding and capacity to address identified challenges.
- ▶ Each community leaves with a project plan to address EJ issues and IEC helps them engage a coalition of stakeholders to solve EJ challenges



EPA THRIVING COMMUNITIES TECHNICAL ASSISTANCE CENTERS (TCTAC)

► Goal:

- Connect disadvantaged communities with federal funding and provide technical assistance

► Milestones:

- Develop target communities
- Establish federal funding resources
- Assist communities in Iowa to be competitive for federal funding

EPA TCTAC PROCESS

- ▶ **Step One:** Disadvantaged communities experience EJ burden and shares experiences with IEC/partners
- ▶ **Step Two:** IEC works with community leaders to identify potential solutions/funding
- ▶ **Step Three:** IEC connects communities with HEJC for technical assistance & application assistance.
- ▶ **Step Four:** Community submits funding application(s)
- ▶ **Step Five:** Communities receive federal funds to alleviate the challenges they face, IEC supports

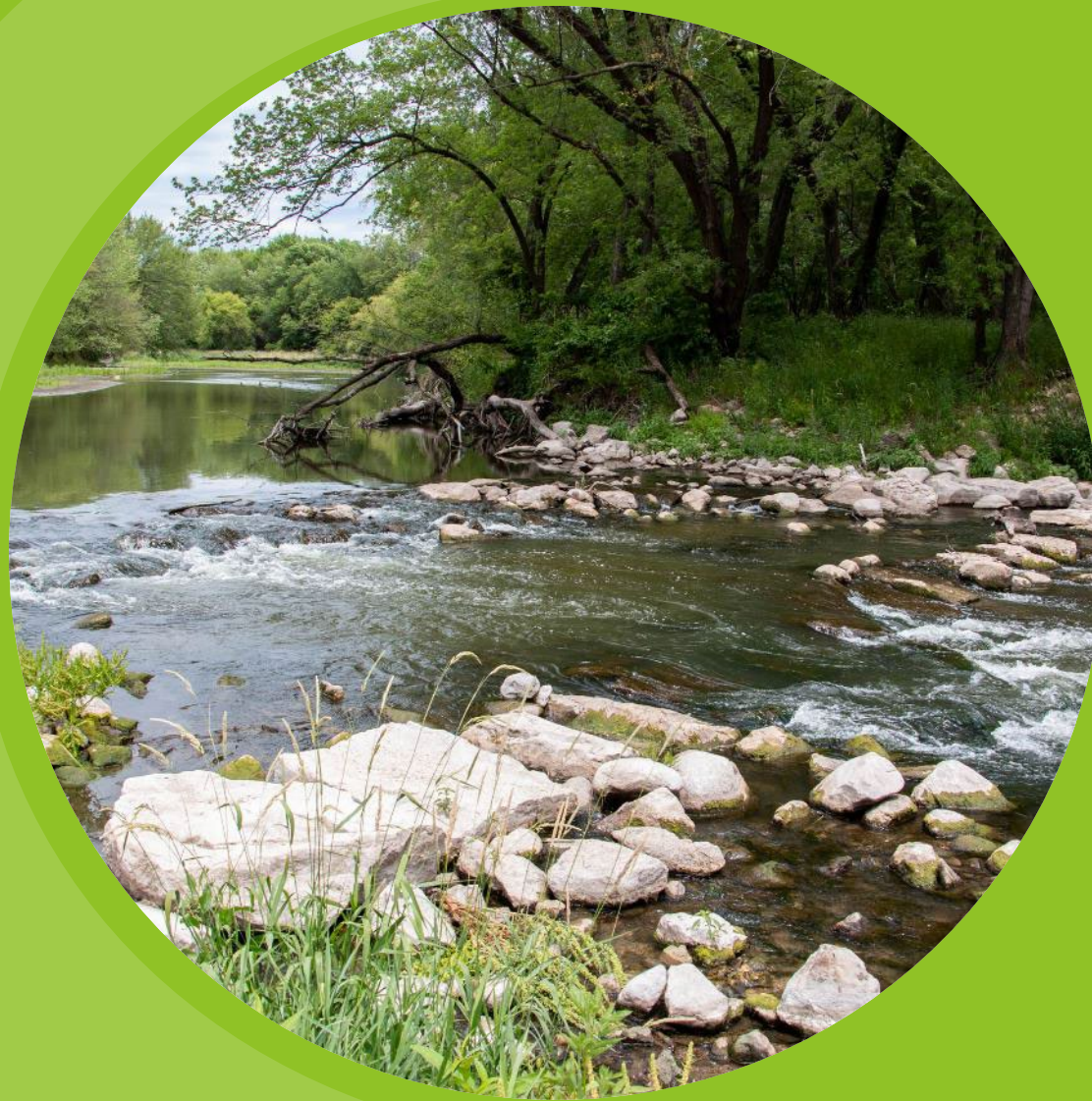
